The person can check with whomever was supposed to deliver the summons, whether that is the sheriff, or a special process server, to see if the summons was delivered.

When a sheriff serves the defendant, they give the defendant a copy of the summons, complaint, and tracking notice. Then, the sheriff fills out the second page of the summons, called Return of Service. Return of Service is proof that the defendant was served. Once this is completed, the original summons (not a copy) must be filed with the court.
